

## MEMORANDUM OF UNDERSTANDING

### ON THE ORGANIZATION OF INDUSTRIAL PhD EDUCATION BETWEEN THE COMMITTEE OF THE CADASTRY OF THE REPUBLIC OF ARMENIA AND THE NATIONAL UNIVERSITY OF ARCHITECTURE AND CONSTRUCTION OF ARMENIA

The Cadastre Committee of the Republic of Armenia (hereinafter referred to as the Committee) represented by its head Suren Tovmasyan, and the Foundation of the National University of Architecture and Construction of Armenia (hereinafter referred to as the University) represented by Rector Yeghiazar Vardanyan, acting on the basis of the charter, on the other side (hereinafter also referred to as the Parties), signed this Memorandum of Understanding (hereinafter referred to as the Memorandum) on the following:

#### 1. PURPOSE OF THE MEMORANDUM

- 1.1. The purpose of this Memorandum is to involve young people who want to carry out research activities into the Committee's system in order to carry out the necessary research works of the Committee, as well as to provide the Committee's employees with the opportunity to receive postgraduate education and write a research thesis.
- 1.2. The Committee, emphasizing the university-state body connection, the problems in the field and the implementation of research works necessary for their solution, gives the opportunity to young people who want to specialize in the field, as experts, to get involved in the work of the Committee.
- 1.3. The willingness to involve an expert in the Committee's departments is due to the involvement of new professional resources in the fields of state registration of rights and restrictions to real estate, real estate valuation, real estate accounting, measurement, land construction, geodesy and cartography, as well as information technology, improving research capabilities and solving existing sector problems with the aim of increasing efficiency.
- 1.4. The cooperation carried out within the framework of this Memorandum is based on the global experience of organizing industrial PhD education and is carried out with the good will, mutual respect and trust of the Parties.

#### 2. ACTIONS OF THE PARTIES

- 2.1. The Committee, in cooperation with the University, can carry out the necessary research works both through its employees and employees engaged as experts, considering their study at the University as a PhD student or doctoral student as a prerequisite.

- 2.2. The formulation of the industrial PhD and doctoral studies and the admission of postgraduate studies at the University are carried out according to the 2016 of the RA Government in accordance with the "Rules for the admission and study in PhD or doctoral programs in the Republic of Armenia" and the internal legal acts of the University adopted by the decision N-238 of February 25.
- 2.3. In order to carry out the necessary research works and obtain postgraduate education, the parties show possible support and involvement in order to have the best results.
- 2.4. The parties may implement other relevant measures arising from the objectives of this Memorandum by mutual agreement.

### **3. TERMS OF THE MEMORANDUM**

- 3.1. The Memorandum does not create any legal and financial obligations for the Parties.
- 3.2. The legal and financial relations arising as a result of the Committee's employee's PhD study at the University and possible involvement of PhD or doctoral students as experts in the Committee's system are regulated by the current legislation of the Republic of Armenia and the internal legal acts of each party.
- 3.3. The problematic issues related to this Memorandum are solved between the Parties through negotiations and consultations.

### **4. PROCEDURE FOR CHANGES AND ADDITIONS IN THE MEMORANDUM**

- 4.1. Any changes or additions to the provisions of this Memorandum must be made by mutual written consent of the Parties.
- 4.2. Each amendment and addition is an integral part of the Memorandum.

### **5. ENTRY INTO FORCE OF THE MEMORANDUM OF UNDERSTANDING**

- 5.1. The memorandum enters into force from the moment of signing and is valid for a period of five years.
- 5.2. The memorandum is made in Armenian language, in two copies with equal legal force. One copy is given to each Party.
