## MEMORANDUM OF UNDERSTANDING

# ON POSTGRADUATE EDUCATION BETWEEN THE CADASTREE COMMITTEE OF THE REPUBLIC OF ARMENIA AND YEREVAN STATE UNIVERSITY

Հայաստանի Հանրապետության Կաղաստրի կոմիտեն (այսուհետ՝ Կոմիտե) ի դեմս դեկավար Սուրեն Թովմասյանի, և Երևանի պետական համալսարանը (այսուհետ՝ Համալսարան) ի դեմս ռեկտոր Հովհաննես Հովհաննիսյանի, որը գործում է կանոնադրության հիման վրա մյուս կողմից (այսուհետ՝ նաև Կողմեր), կնքեցին սույն փոխըմբռնման հուշագիրը (այսուհետ՝ Հուշագիր) հետևյալի մասին. The Cadastre Committee of the Republic of Armenia (hereinafter referred to as the "Committee"), represented by its Head Suren Tovmasyan, and the Yerevan State University (hereinafter referred to as the "University"), represented by Rector Hovhannes Hovhannisyan, acting on the basis of the Charter of the University, on the other hand (hereinafter referred to as the "Parties"), have signed this Memorandum of Understanding (hereinafter referred to as the Memorandum) regarding the following:

### 1. PURPOSE OF MEMORANDUM

- 1.1. The purpose of this Memorandum is to bring young people who wish to carry out research activities into the Committee system to carry out the necessary research work of the Committee, and to provide the Committee staff with opportunities for postgraduate education and Write a scientific thesis through application (postgraduate, doctoral) and the same procedure as for university. Postgraduate students are accepted.
- 1.2. The Committee, emphasizing the connection between the university and the public body, the problems in the field, and the research work necessary to solve them, gives young people who wish to specialize in the field the opportunity to get involved as experts in the work of Committee.
- 1.3. The readiness to attract specialists to the Committee's subdivisions is conditioned by attracting new professional resources in the spheres of state registration of rights and restrictions on immovable property, real estate valuation, registration of immovable property, land surveying, land management, geodesy, and cartography, as well as information technology, improving research capacity and solving existing problems of the sector to increase efficiency.

1.4. The cooperation carried out within the framework of this Memorandum is based on the world experience of organizing postgraduate industrial education and is carried out with goodwill, mutual respect and trust of the Parties.

### 2. ACTIONS OF THE PARTIES

- 2.1. The Committee, in cooperation with the University, may carry out the necessary research work both through its own staff and through staff engaged as experts, considering as a prerequisite their application to the University or the fact of being in postgraduate or doctoral studies.
- 2.2. Admission to PhD, doctoral studies and admission to postgraduate studies at the University is carried out in accordance with the RA Government Decree of 2016. in accordance with the "Procedure of Admission and Study in Postgraduate, Doctoral and PhD Studies in the Republic of Armenia", adopted by the decision N-238 of February 25, and the internal legal acts of the University.
- 2.3. For the necessary research work and postgraduate education, the parties shall provide possible support and participation in order to achieve the best possible results:
- 2.4. The Parties may implement other appropriate measures arising from the purposes of this Memorandum by mutual agreement.

#### 3. TERMS OF MEMORANDUM

- 3.1. The Memorandum does not give rise to any legal olligations for the Parties
- 3.2. The legal and financial relations arising as a result of the registration of co-researchers (postgraduate, doctoral students) of the Committee's employee at the University for the purpose of postgraduate education and possible involvement of co-researchers, postgraduate or doctoral students as experts in the Committee's system shall be regulated by the current legislation of the Republic of Armenia and internal legal acts of each Party.
- 3.3. Problematic issues related to this Memorandum shall be resolved between the Parties through consultations and negotiations.

## 4. PROCEDURE FOR MEMORANDUM AMENDMENT

- 4.1. Any changes or additions to the provisions of this Memorandum shall be made by mutual written agreement of the Parties.
- 4.2. Each amendment and supplement shall form an integral part of the Memorandum.

## 5. ENTRY INTO FORCE OF THE MEMORANDUM OF COOPERATION

- 5.1. The memorandum will enter into force after the signature by both Parties of five years.
- 5.2. The memorandum is written in Armenian language, in two copies with equal legal force. One copy is given to each Party.
